

Tribe's plan for smaller casino raises question of payments to local governments

Plans by a Butte County tribe to start building a small casino in Yuba County are bringing into focus 13-year-old agreements that would bring additional cash to Yuba County and Marysville.

Yuba County supervisors next week are expected to discuss a 2002 memorandum of understanding with the Estom Yumeka Maidu Tribe of Enterprise Rancheria related to a proposed class III casino. The agreement calls for the county to receive \$83 million over 20 years to mitigate the impact of gaming.
